PUBLICATIONS, FORMS, CERTIFICATES, DOCUMENTS AND MARINE SAFETY CIRCULARS

Every document and publication issued is preceded by the initials 'CD' for "Commonwealth of Dominica."

Publications have the precursor 'CDP' (Commonwealth of Dominica Publication) and fall into the following general categories:

100	Legal and Regulatory
200	Vessel Registration & Mortgage Recordation
300	Marine Personnel
400	Casualty Investigations
500	Circulars and Directives
600	Operations

1000	Internal Administration
2000	Registration Documents
3000	Certificates
4000	Sample Documents
5000	Personnel Documents
6000	External Administration

For Example: CDMP-3025 is readily identified as a Commonwealth of Dominica Certificate that deals with Marine Personnel.

MARINE SAFETY CIRCULARS AND DIRECTIVES

All Circulars will be issued with the Precursor – CD-MSC followed by a sequential number and year of issue—CD-MSC 1-01; CD-MSC 2-01; CD-MSC 3-01; etc. For example, CD-MSC 1-01 is identified as Marine Safety Circular number 1, issued in the year 2001.
